




- Tennessee had a
 4.9% unemployment
 rate in February, a
 decrease from
 January 5.1% rate.
 Tennessee's rate has
 declined dramatically
 from its 15.5 % peak.
- The U.S. unemployment rate fell to 6.2% in February, a notable decline from the 14.7% peak in April. Tennessee's rate is much below the national average.



- Total non-farm Tennessee February employment is down 3.8% compared to last year. Tennessee has seen decline across most sectors, with Leisure & Hospitality down 15.8% and Manufacturing 3.4% lower than last year. Tennessee's employment losses are much lower than the national average.
- The U.S. gained 379,000 jobs in February, and employment remains 6.2% below last year. The greatest decline has been in Leisure & Hospitality, falling by 20.4%. Employment has fallen by more than 10% in Mining & Logging.



Figure 3: Growth in Sales & Use Tax Collections

 Sales taxes increased 15.7 percent in February, after rising 9.4 percent in January and 6.6 percent in December, Tax collections are based on sales during the previous month. Collections by marketplace facilitators have significantly increased sales tax revenues. Building materials, catalog sales, general merchandise, and vehicles all showed very strong growth during January (February's collections).



 Total tax revenues were up 11.1 percent in February, continuing the pattern since December of very strong increases. Sales taxes, corporate taxes and privilege taxes grew very rapidly, while some others fell. July tax collections were elevated and April collections lowered because deadlines for filing several taxes were delayed until July.



Updated monthly; last revision 3/18/21.




- Sales taxes rose in 94 counties in February. Most counties are seeing strong revenue growth because of marketplace facilitator remittance combined with the sales tax now being collected on a destination basis. Eighty-eight counties saw revenue growth above 20 percent in February.
- •Only Davidson and Moore counties have experienced a sales tax decrease for the fiscal year to date.

Updated monthly; last revision 4/1/21.




- Nine counties had lower unemployment rates in February 2021 than the previous year. The rate was more than 1 percent higher than last year in only 17 counties.
- Forty-three counties had unemployment rates under 5 percent, with 11 below 4 percent. Only three counties were above 7 percent.



• Five counties had higher employment in February 2021 than the previous year. About two-thirds of counties have lost between 2.0 percent and 6.0 percent of their employment over the year. Unemployment rates tend to be lowest in middle Tennessee but these counties generally have significantly lower employment than last year.
